## Did you know?

- Common County Code violations involve:
  - unlicensed or inoperable vehicles
  - recreational vehicles and equipment
  - trucks parked in residential areas
  - discarded materials
  - grass and weeds
- Disabled and unlicensed vehicles on the street can be towed.
- County Planning/Zoning can enforce where trailers/boats are parked (should be behind back plane of house).
- Vehicles parked on street cannot block emergency vehicle access and vehicles cannot block driveways and mailboxes.

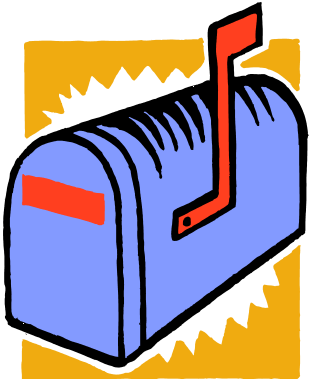
## **Mail Boxes and Posts**

Many mail boxes and posts in the neighborhood are in need of repair and/or repainting. Now is a great time to get them back into shape – **before** you get a violation letter.

Both the box and post must be maintained and meet the community standards for **STYLE, SIZE, and COLOR**. The mail box must be a black color. The post must be a cream color (NOT white).

You can obtain the correct post paint for \$2.00 per container from any Board member.

## **Selling Your Home?**

Remember that under Virginia law you, as the seller, are required to provide the buyer with a "disclosure packet" from the Stoney Glen West Association for your property **BEFORE** closing.

A \$50.00 fee is required to be paid to the Association for the packet.

Contact Dave Foley at 768-0157 at least 2 weeks in advance to request a packet. You must provide adequate time for packet preparation. ***Please do not wait until the last minute to request your packet.***

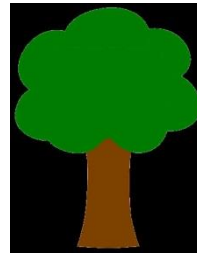


For the safety of all, please remember to obey all traffic laws and signs throughout our community!

REMEMBER! PICK UP AFTER YOUR DOGS & QUIET BARKING DOGS

Be sure to pick up anything your dog "drops" and please dispose of your collections in your home trash can. Do NOT drop those plastic collection bags into the storm sewers. Also, keep in mind that county ordinances provide that residents can incur a county fine if a dog barks once a minute for 10 consecutive minutes. Your neighbors appreciate your efforts to quiet barking dogs.
